1. Description of product

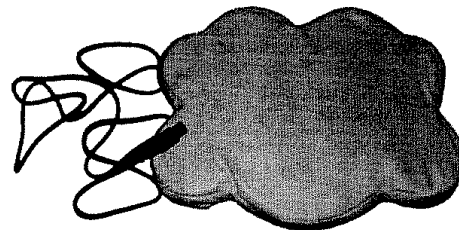
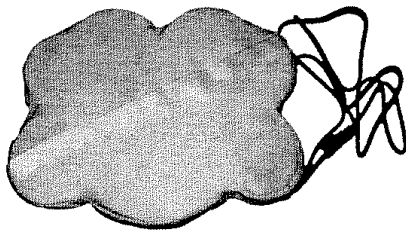

5. Quality Control Measures

- 5.2 The examination to complete the checklist to the essential safety requirements for toys of the Council Directive 2009/48/EC and demonstrate that the product has been manufactured to relevant national standards.
- 5.3 To ensure that future additions to the product range or any alterations to the current products are manufactured to the same standard, the following points are to be observed;
 - 5.3.1 Before appointment of new materials suppliers, documentary evidence that the materials to be used in the range are compliant to BS EN 71 shall be obtained and incorporated into this file.
 - 5.3.2 Additions to the range shall be assessed to check compliance with the relevant parts of BS EN 71, before the CE mark is affixed.
 - 5.3.3 PlingToys will be responsible for updating this technical file to incorporate any new supplier/product information, but external advice should be sought in any situation of doubt. Conformance Ltd, or similar, would be very happy to assist in any such matter.
